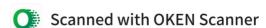

#### Introduction:

A one-day workshop on the "Indian Constitution and Protection of Women" was successfully conducted at SVPP Seminar Hall on1st Oct 2024. The workshop aimed to raise awareness about women's rights, as enshrined in the Indian Constitution, and discuss the mechanisms for protecting women from violence and discrimination. It attracted participants from various sectors, including students, legal professionals, social workers, and representatives of women's organizations.

## **Objectives:**

- i. To provide an overview of the provisions in the Indian Constitution related to gender equality and women's rights.
- ii. To educate participants on laws and policies aimed at protecting women.
- iii. To discuss the role of institutions in safeguarding women's rights. To raise awareness of how constitutional rights are implemented in real-life scenarios.
- iv. To empower women by enhancing their understanding of legal remedies available for protection.

## **Inaugural Session:**

The workshop began with an inaugural session, where Adv. M. S. Lagad (President Human Rights Foundation Shrigonda) & Advocate G.R.Kokate, gave a welcome speech highlighting the significance of women's empowerment in India's democratic setup. The speaker stressed the importance of understanding constitutional provisions and laws that protect women from harassment, violence, and discrimination.

#### **Key Sessions and Presentations:**

1. Overview of the Indian Constitution and Women's Rights: The first session provided participants with a detailed presentation on the fundamental rights guaranteed by the Indian Constitution. The speaker explained Articles 14, 15, 16, and 21, which focus on equality, non-discrimination, and the right to life and personal liberty, with special emphasis on gender equality.

2. Legal Provisions for Women Protection: A legal expert presented keep that protect women in India, such as:

The Protection of Women from Domestic Violence Act, 2005

The Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act, 2013

The Dowry Prohibition Act, 1961

The Criminal Law (Amendment) Act, 2013 (covering changes after the Nirbhaya case) the expert also explained the legal procedures for reporting crimes against women and how victims can seek justice.

### 3. Role of Law Enforcement and Judiciary:

This session involved a detailed discussion on the role of law enforcement agencies and the judiciary in protecting women. A senior police officer shared insights on the functioning of women's cells, the process of filing FIRs, and the significance of fast-track courts for handling cases related to women.

#### 4. Interactive Panel Discussion:

A panel of experts, including legal professionals, activists, and academicians, engaged in an interactive discussion with the participants. The session covered challenges faced by women in accessing justice, social and cultural barriers, and the role of civil society in creating a safer environment for women.

### Key Takeaways:

A deeper understanding of constitutional provisions regarding women's rights.

Practical knowledge of the laws and procedures for seeking legal protection.

The need for continued education and outreach to ensure that women in rural and urban areas are aware of their rights.

Recommendations for stronger implementation of legal frameworks to prevent violence against women.


